MEMORANDUM OPINION

PRESENT: CHAGARES, Chief Judge.

This complaint is filed under the Judicial Conduct and Disability Act, 28 U.S.C. §§ 351-64, against a United States Circuit Judge ("Subject Judge"). For the reasons discussed below, the complaint will be dismissed.

The Judicial Conduct and Disability Act provides a remedy if a federal judge "has engaged in conduct prejudicial to the effective and expeditious administration of the business of the courts." 28 U.S.C. § 351(a). A chief judge may dismiss a complaint if, after review, he or she finds it is not cognizable under the statute, is directly related to the merits of a decision or procedural ruling, or is frivolous or lacks sufficient evidence to raise an inference of misconduct. 28 U.S.C. § 352(b)(1)(A)(i)-(iii).

Although not clear, it appears Complainant unsuccessfully attempted to file documents as an "interested party" in a high-profile murder trial that took place in a federal court outside of this Circuit. Complainant alleges that those documents were

"thrown in the dumpster by clerks, etc.," resulting in the alleged falsification of records "and other heinous acts." Complainant contends that these actions demonstrate racial bias against Complainant and violated Complainant's constitutional rights.

Due to recusals, the Subject Judge served by designation in the appeal from the judgment and conviction in the out-of-circuit murder trial. Complainant alleges that the Subject Judge and others "bungled into" that case "to commit racist malice murder and unlawful imprisonment and a slew of misconducts and retaliate against [Complainant]."

Upon review, the record reflects no basis for a determination that the Subject Judge engaged in conduct prejudicial to the effective and expeditious administration of the business of the courts. This complaint therefore is subject to dismissal as frivolous and unsupported by evidence that would raise an inference that misconduct has occurred. 28 U.S.C. § 352(b)(1)(A)(iii); Rule 11(c)(1)(C), (D), Rules for Judicial-Conduct and Judicial-Disability Proceedings. To the extent Complainant's allegations are intended to challenge the disposition of the appeal in the murder trial, such allegations are related to the merits of a judicial ruling and are therefore not cognizable. Rule 4(b)(1), Rules for Judicial-Conduct and Judicial-Disability Proceedings ("Cognizable misconduct does not include an allegation that calls into question the correctness of a judge's ruling, including a failure to recuse."); see also 28 U.S.C. § 352(b)(1)(A)(ii); Rule 11(c)(1)(B)

Based on the foregoing, this complaint will be dismissed pursuant to 28 U.S.C. § 352(b)(1)(A)(ii) and (iii).

On the basis of the foregoing opinion entered on this date, it is ORDERED AND ADJUDGED that the written complaint brought pursuant to 28 U.S.C. § 351 is hereby dismissed under 28 U.S.C. § 352(b)(1)(A)(ii) and (iii).

This order constitutes a final order under 28 U.S.C. § 352(c). Complainant is notified in accordance with Rules 11(g)(3) and 18, Rules for Judicial-Conduct and Judicial-Disability Proceedings, of the right to appeal this decision by the following procedure:

Rule 18(a) <u>Petition</u>. A complainant or subject judge may petition the Judicial Council of the Third Circuit for review.

Rule 18(b) <u>Time</u>. A petition for review must be filed in the Office of the Circuit Executive within **42 days** after the date of the chief judge's order.

18(b) <u>Form</u>. The petition should be in letter form, addressed to the Circuit Executive, and in an envelope marked "Misconduct Petition" or "Disability

Petition." The name of the subject judge must not be shown on the envelope. The letter should be typewritten or otherwise legible. It should begin with "I hereby petition the judicial council for review of . . ." and state the reasons why the petition should be granted. It must be signed. There is no need to enclose a copy of the original complaint.
