Submit New Case with Fee Payment

Third Circuit Court of Appeals public filers may electronically submit an Immigration Petition for Review, Other Agency Petition for Review, Petition for Writ of Mandamus, Application and Cross Application for Enforcement of an Agency Order for filing with the court. Acceptable forms of payment are credit/debit or electronic check. Filers are required to comply with service of the filing in accordance with FRAP 25.

- 1. Log into Third Circuit Court of Appeals Electronic Filing System.
- 2. From the Startup page, select Utilities menu option.

- 6. Enter the description of the document in the **Description** field.
- 7. Click the **Browse** button to upload the PDF document that is being submitted for filing.

- 9. To submit an additional document, enter a description of the additional document in the **Description** field.
- 10. Click Browse to upload any additional documents.
- 11. If submitting more than one additional document, each document should be entered and uploaded separately.
- 12. Click the **Pay Fee and Submit** button to launch the payment program.
