The States of Texas, New Mexico, and Colorado (the Compacting States) request clarification with respect to the Status Conference scheduled for February 27, 2025. That Status Conference is scheduled to follow two and one-half days of further mediation. The Compacting States are concerned with the delay in scheduling further mediation and, consequently, discussed with the Mediator that mediation should be in conjunction with a Trial Setting Conference. We are uncertain and seek clarification on whether the Status

Conference in February would be the most efficient use of the Parties' time and

resources. If the February 27 Status Conference will include a Trial Setting

Conference, we also request clarification of submissions that the Special Master

will require.
